PRINCIPAL RESEARCH INTERESTS Maintaining the integrity of Earth’s Biosphere; integrative framing of science, ethics, and praxis in human development and application of solutions to environmental issues and problems; wetland ecosystem development and role in sequestering carbon, phosphorus, and atmospheric solutes and particulates in maintaining a habitable earth; strategies for addressing climate change across cultures, differing perspectives, and religion and science; integrative wetland science; limnogeology; karst geology; groundwater systems and stewardship in relation to wetlands, lakes, and municipal high-capacity wells policy; thermoregulatory systems and land stewardship at local and global levels; atmospheric, oceanic, and climate stewardship; interfacing of ethical, religious, economic, and governmental systems toward long-term health and sustainability of the biosphere; missiological contextualization within biospheric processes and ecosystem services; integrative scholarship across biblical and scientific understandings of ecological restoration and stewardship; and integrative biogeographic and trophic interactions in sustaining the biospheric economy.

CURRENT RESEARCH Addressing global climate change; science and religion in dialogue on the biospheric economy; wetland carbon sequestration in maintaining a habitable biosphere; conservation leadership development; application of integrative interdisciplinary frameworks for science, ethics, and praxis; defending the Endangered Species Act; integrative wetland science; strategic translation of environmental and global climate change science and ethics into practice by American evangelicals; strategic implementation of integrated ethics and science in U. S. faith communities; implications of *Laudato Si’* for biology and ecology; biospheric missiology; and biogeographic and maintaining integrity of the biospheric economy.

Principal TEACHING *Principles of Environmental Science* (Envir St 126): a four-credit environmental systems course, with lecture, lab, and field, given during both spring and fall semesters across the full span of my UW teaching career. Its focus each semester was on the subjects of Science, Ethics, and Praxis integrated interactively and directed toward achieving and maintaining the integrity of the Biosphere through the practice of environmental stewardship from local to global scales.

Environmental Internship Capstone (Envir St 600): in this practical course, I supervised internships in conservation leadership development for 20-25 senior undergraduates in environmental and conservation-based organizations during the spring semester.

Field Investigations in Wetland Ecology (Envir St 710): a course given on Waubesa Wetlands in which graduate students select a significant research problem, conduct research on this in teams of 2 or 3, prepare a paper to meet professional standards, and present their findings to wetland neighbors, ecologists, and local government leaders. Much of the work of these graduate students over the years is contained in the book, *Waubesa Wetlands: A New Look at an Old Gem*, by the UW Aldo Leopold Chair of Restoration Ecology, available at the Town Hall of the Town of Dunn, and on the town website.

Mentor of Duke Conservation Fellows: my mentoring of these 4-6 fellows annually included participating with them in an annual retreat at the National Conservation Training Center at Shepherdstown, West Virginia, and advising during the academic year.

Yahara Watershed Academy: in this endeavor of the Clean Lakes Alliance I currently teach the unit on wetlands of the Yahara Watershed each spring semester, including an on-site review of research on Waubesa Wetlands conducted over the past several decades.
